In order to use the service/participate in sports and entertainment activities at Jump Arena center of Jump Arena Joint Stock Company (hereinafter referred to as "Jump Arena"), I hereby commit that:

1. I have full capacity for civil acts, awareness, alertness, health, and volunteer to participate in activities/games at the center and sign this Waiver Form.
2. I accept and commit to comply with the "Trampoline Court Rules", which publicly posted at the center and have read and understood the contents and provisions stated in this Commitment.
3. I commit to accept and comply with the rules as follows:
 - a. Do not participate in any activities, games, or trampoline games when being affected by drugs, stimulants, or alcoholic beverages.
 - b. Properly use all trampolines, climbing safety equipment, and other provided equipment as instructed.
 - c. Do not participate in any activities or trampoline games when having any pre-existing medical conditions; or having problems with the circulatory system, heart, lung, back, neck; just had surgery; high blood pressure; have had a spinal injury, skeletal muscle injury or head injury; or if being or may be pregnant.
 - d. Avoid colliding with other players while participating in the games.
 - e. Comply with the rules about age, height, or weight when playing according to instructions of the manufacturer or Jump Arena to use trampolines or participate in the trampoline games and other activities.
 - f. The total weight must not exceeding 150kg.
 - g. Do not use trampolines when there are too many people and avoid jumping on the same trampoline with another player.
 - h. Do not perform any dangerous acrobatic movements without prior guidance on acrobatic techniques from Jump Arena's staff.
 - i. Do not climb or hang yourself on the inclined mattress.
 - j. For your own safety, do not land on the floor or the edge of the trampoline.
 - k. Do not throw balls or objects at other people.
 - l. Do not sit or lie on the trampolines.
4. In case of taking children/minors along:
 - a. To participate in the games, children must be at least 02 years of age.
 - b. In case of taking children under 6 years of age along, I undertake that I am the parent/legal guardian of the children in accordance with the law.
 - c. In case of taking children/minors aged 06 or older along, I undertake that I am the parent/legal guardian, or I have received approvals from the parent/legal guardian of the children/minors.
 - d. The person who take children/minors along is responsible to pick up and take care of the children/minors after finish playing time at the center. In any cases, Jump Arena is not responsible for taking care of the children/minor after finish playing time at the center.
5. I commit that all information and content that I confirmed in this Commitment is true and will undertake all arising responsibilities (if any) of any untrue commitments.
6. In any cases, Jump Arena understands that the commitment of the person, who signed this Commitment is true and Jump Arena has no obligation to verify the content of the commitment.
7. Jump Arena has the right to ask players to go out of the playing area if they do not comply with the rules of Jump Arena, or causing nuisance or danger to other players, staffs, and visitors.
8. I am fully aware of all the risks and accidents that may occur when participating in the activities, including but not limited to physical and psychological injuries, personal injuries, loss or damage to property. In the event of any risks or accidents occurring through no fault of Jump Arena, I undertake to waive all relevant responsibilities for Jump Arena and waive all right to complain, sue, denounce, all harmful acts to Jump Arena in relation to or arising from my use of services/participation in the activities and entertainment at Jump Arena.
9. This Commitment is also applicable for children/minors who is taken along with me (if any).
10. This Commitment shall take effect from the signing date until the end of December 31, 2021.

By signing this Waiver, I agree to all of the content of this Commitment and provisions, terms and conditions in relation to Jump Arena's activities, services and policies and any adjustments from time to time, including allowing Jump Arena to use or transfer personal information declared in the Commitment, and my photos, audio, video recording to other third parties to introduce, advertise, or execute promotions, getting points or other customer programs as determined by Jump Arena.
